

**NOTICE OF TOWN BOARD OF THE TOWN OF RUSH PUBLIC HEARING ON FOREFRONT
POWER, LLC'S SOLAR ENERGY SYSTEM OVERLAY DISTRICT APPLICATION AND SITE
DEVELOPMENT PLAN WITHIN THE TOWN OF RUSH**

PLEASE TAKE NOTICE, a public hearing will be held by the Rush Town Board, at the Rush Town William R. Udicious Pavilion, 5977 East Henrietta Road, Rush, New York (the "Pavilion"), on the **22nd day of July at 7:15 PM**, local time, for the purpose of considering the Solar Energy Systems Overlay District application and site development plan for the development of the Werner Solar 4 megawatt (MW) alternating current (AC) photovoltaic Array on 22.28 acres of an approximately 116.48-acre parcel of land located at 8427 West Henrietta Road, Rush, New York.

At such hearing any person may be heard in favor of or against the overlay district application and site development plan as proposed at the above time and date.

Based upon notices and health advisories issued by Federal, State and Local officials related to the novel COVID-19 virus, due to public health and safety concerns associated with the potential gathering of a large number of individuals who may wish to submit public comment, the public will not be permitted to attend the public meeting in person at the Pavilion or Town Hall. The public will have an opportunity to see and hear the meeting live and provide comments during the public hearing via Zoom video conference.

INSTRUCTIONS TO ACCESS THE VIRTUAL MEETING: If you have a computer, tablet or smartphone, you *MAY* have to create your own account using an e-mail address and password. It is free. You will need a device, tablet, or computer with internet. You can also use the Zoom app if you download through the Apple store or Android store.
