## Dear Residents:

I would like to welcome Spring back to our community. Nature's signs of robins, geese, and tree buds are all pointing the way. Many thanks to Mark David and the highway crew for their great work over this past winter.

The Supervisor of your town needs to complete various training to stay current with the job. Within the past 2 months the following training has been completed:

1. Healthcare Reform Update (Obamacare) for employers with less than 50 people.
2. Healthcare Reform Update (Obamacare) for municipal employers.
3. Emergency Management Public Official Workshop given by FEMA.
4. Analysis of stable rate pension option vs normal contribution state pension-which is currently 21% of our payroll.

## PLANNING & ZONING BOARD APPLICATIONS

Many of you have inquired about the outcomes of Planning Board (PB) and Zoning Board of Appeals (ZBA) applications. Because the town newsletters are published bi-monthly, the ZBA and PB news sometimes becomes old news. So that you may be informed, (as a town courtesy and not a legal obligation) we send out a notice to all residents within 500 feet of parcels being discussed at meetings. Depending on deadlines, all public hearing notices are published in the Sentinel and/or the Henrietta Post. All of the meeting agendas, minutes, and applications and decisions are posted on the town website at [www.townofrush.com](http://www.townofrush.com). Below is a brief synopsis of most recently heard applications before the PB and ZBA.

### YELLOW DOT KITS AVAILABLE HERE

What is it? The NYS Sheriff's Department Yellow Dot Program is designed to help first responders provide life-saving medical attention during the first "golden hour" after a crash or an emergency. A Yellow Dot in the driver's-side rear window of your vehicle will alert first responders that vital medical information is stored in the glove compartment. Placing the yellow decal at your front door will direct first responders to vital information stored in your freezer. Just a reminder once again that building permits do not always get the attention they should. In the past few months there have been several cases of construction taking place and no permit on file. Building anything on your property without the required permit can cause many problems, especially when you want to sell the property. So make sure you obtain the required permit(s) before you start that project. If you are unsure you can call me.

The following list should involve the purchase of a permit when you are planning your next project:

- All dwelling construction
- All agricultural use construction
- All swimming pools
- All fence construction
- All sheds, barns, garages, etc.
- All re-roofing
- Back-up generators
- Door and window replacements
- Underground tanks
- Electrical repairs and additions
- MOST signs
- HVAC system replacements
- Some interior remodeling
- All solid fuel appliances
- plumbing and waste system alterations
- any demolition
- all decks
- electrical inspections must be done by a licensed underwriter

### TOWN WIDE BRUSH PICK UP

The Highway Department will be conducting its annual brush pick up along all roads in Rush commencing April 22<sup>nd</sup>, weather permitting. We eagerly encourage residents to utilize this service.

Pick up will begin on the west side of town and continue east until complete. Once a road is completed, there will be no return trips. Since we are unable to inform you of the exact day that we will be working on your street, it is suggested that you have your brush ready for by April 22<sup>nd</sup>.

### GUIDELINES

- Residential pick up only.
- Brush shall be no longer than 15 feet in length.
- Brush shall be placed parallel to the roadway, and neatly stacked.
- Brush piles shall be placed 6-10 feet from shoulder of roadway.
- Do not place brush directly under overhead wires.
- Do not place brush over utility shutoffs.
- Condensed larger piles are easier for us than multiple small piles.

### WHAT WE DON'T ACCEPT

Any manmade construction materials including dimensional lumber, landscape ties, metal or other trash. Stumps should be clean of rocks and soil.

The transfer station located on Stonybrook Rd. opposite the Town Park is open and maintained 24/7. Town residents may drop off acceptable materials generated within the Town at their convenience.

Leaving the gates unlocked has been working well and we have had minimal dumping of unacceptable materials. Keep up the good work.

### LAWN DAMAGE REPAIRS

Early spring weather will have the Highway crew out repairing lawn damage from plowing. If we overlooked any areas, please call and let us know. Snow fencing will also be coming down and then it's time to remove the snow plows, wings and salters from the trucks. Preventative maintenance and painting on all winter equipment will have us ready for brush pick up and summer road work projects.

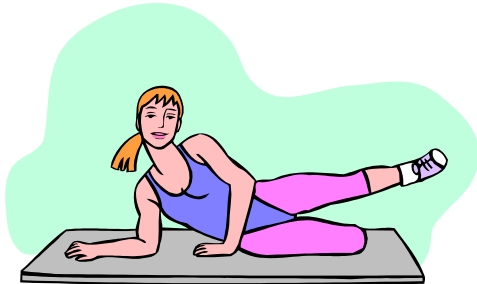
I have been asked by the President of the Rush seniors group to put in the town newsletter my background and knowledge of community services for the elderly population.

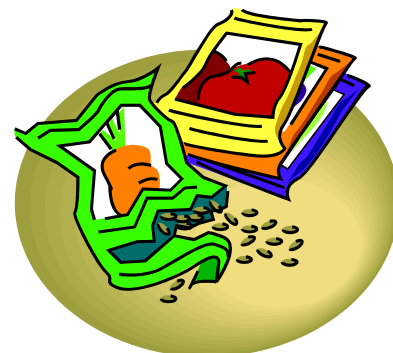

The Rush Seniors met on Valentine's Day and enjoyed a delicious (as usual) lunch, an informative meeting and Bingo. VP Linda Price reviewed the after-meeting entertainment for the year and Jim Oliver revealed our 2013 trip schedule. Jim has organized an event for every month; with our extended trip to Washington D.C. scheduled for September 4<sup>th</sup>-7<sup>th</sup>.

Our March meeting entertainment featured the Rush Henrietta Women's Mixed Chorus and the Senior High Mixed Chorus. Both groups did a terrific job and were greatly enjoyed.

**TRAVEL & EVENTS:** The club will be travelling to Buffalo on Saturday, April 20<sup>th</sup>. The trip includes shopping at Vidlers and the Made In America store, lunch at the American Grille and a Smith Theatre presentation of Late Night Catechism Las Vegas: "Sister Rolls the Dice".

Recently, we have received some inquiries at the town hall requesting information on how to prevent break-ins to vehicles and property, so for this edition of the newsletter I thought I would share some tips on the subject as provided to me by local law enforcement authorities.

According to FBI statistics, burglaries are down approximately 10% nationwide. But according to the Chicago-based Burglary Prevention Council, a burglary still happened somewhere in the United States every 11 seconds last year, and the typical burglarized house lost \$1,350, not counting the cost of repairs to broken windows and the like.

So if you want to help the downward trend in burglaries continue there are a few steps you can take to make your house less attractive to thieves, particularly when you're on vacation.

1. Contact the local police department at least one week before you leave on vacation. Some departments offer free crime-prevention inspections. Most police departments tell patrolling officers to keep an eye on a house when they know it is going to be temporarily vacant.
2. Visit your neighborhood post office to have mail delivery stopped if you're going to be out of town. Also stop your newspaper delivery. If you are going to be gone for more than a week, have someone cut your grass.
3. Close and lock all doors when leaving home for even short periods. More than a quarter of all burglary is without forced entry. Make sure you check the doors of the attached garage and breezeway in addition to all windows, including basement windows.
4. Install deadbolt locks on all entry doors. A deadbolt lock is hard to force and doubles your resistance to intrusion. If there are no breakable windows within 40 inches of the lock, you can use a lock with a thumb latch that will let you open the door from the

inside without a key. In doors with glass panels use a key lock with a keyhole on both sides.

5. Secure all windows. You can lock a double-hung window securely and inexpensively by drilling a hole at a downward angle through the front sash where the sashes overlap. A wooden peg in the hole will keep the window from rising. Check home-improvement, hardware or variety stores for other window-locking ideas and devices.
6. Use automatic timers. Some timers can be set to turn on lights, radios and other appliances at the same time each day. Others that are slightly more expensive vary the on and off patterns from day to day to enhance the illusion that someone is home. Setting a timer on a radio tuned to talk-show station might fool burglars into thinking a live conversation is going on if they listen at the window.
7. Illuminate the yard. Outdoor lighting is an effective deterrent to burglars. Energy-efficient low-voltage outdoor lights can eliminate the dark spots where a burglar could hide, and a light with a motion sensor is great way to scare off a potential thief.
8. Lock up ladders, tools and lawn furniture. Don't invite burglary by providing aids to breaking into your house. A sturdy lawn chair that can be pulled under a window makes getting through that window easier.
9. Trim trees and shrubs growing close to the house. To enter your house without making a lot of noise, a burglar needs time to work. Tall bushes and hanging branches can provide shelter while the burglar cases the house or tries to pry open a door or window.
10. Start a neighborhood watch program. Your local police department can help organize a neighborhood watch group that encourages neighbors to watch out for one another. But even without a formal watch group, you should get to know your close neighbors so each of you can help keep the other's house safe.
11. Use window and floor alarms. Look around discount and home-improvement stores for

inexpensive audible alarms that go off when a window or door is forced. Also available are professionally installed systems that automatically call emergency crews when they sense trouble. Before investing in such a system, however, check with police to find out what is legal in your community.

12. Inventory your valuables. Place small valuables and important documents in a safety-deposit box.

Theft from autos is on the rise and so are the efforts of the Sheriff's Office to stop it. Crime prevention has always been a partnership; the police can't do it alone. As police step up their enforcement, we need the public to step up its target hardening efforts.

Our battle cry is — Lock Your Car, Take Your Stuff. What does it mean? It means the bad guys have shifted gears and are now more aggressive than ever. They won't hesitate to smash a window or pry open a vehicle's trunk. So whenever possible, try not to leave valuables in your vehicle at all.

However, if you have no choice, it's certainly best to keep things out of sight and locked in the trunk. Thieves still look for the easiest target and don't want to draw a lot of attention to themselves. Prying open a vehicle trunk with a screwdriver or pry bar does not look normal.

Remember: if we can't always stop them, we can at least slow them down. And then their chances of being seen and caught increase dramatically.

Here are some tips to remember:

- Lock your car and take your valuables with you when possible.
- If you must leave valuables in your car, lock them in your trunk or keep them out of sight.
- Be aware. Look for prying eyes or suspicious individuals.
- Park in well-lighted areas.
- Remove cell phone antennas when possible.

- If making more than one trip to put items in your car while at the mall, consider moving your vehicle to make it look like you've left.
- Consider an alarm system if you must often leave valuables in your vehicle.
- Plan ahead before you go shopping. Purchase small items that can easily remain with you first. Larger items that would probably have to remain in the vehicle and can't be kept out of sight should be purchased last.
- Report suspicious persons. We need to look out for each other.
- Report all crimes to the police.

**FIRE DISTRICT**

**NEW PUMPER:** The new truck committee has received 5 bids for the pumper 585 replacement. The cost is in the \$420,000 to \$440,000 range. We have been working on this project for almost a year to make sure we got it right. We hired a consultant to cut down on the cost and saved over \$70,000 on items we could live without. Other department buying pumpers that are about the same size are paying over \$500,000 for their new trucks.

**MESSAGE SIGN:** We are looking into a message sign for the area in front of the radio room for station one. Members of the fire department and the commissioners are looking over several proposed signs.

**COUNTY EMS STUDY:** \$140,000 was spent on this study. Rush Ambulance was rated above average for a target response time for a rural ambulance service. Two other ambulance services in the county were also above average.

That being said, the study did not have the times correct. We have a first responder with proper EMS equipment on scene on average 6.2 minute 95% of the time. They had us at 13 minutes. We have an ambulance on scene 9.7 minutes – 100% of the

time. They had us at 13 minutes. The study said 911 get the call out within 2 minute and 2 seconds on average. Our records put that time at over 3.25 minutes. They also reported that the City FD was the only agency that sent supervisors to their calls. We have a Chief officer or Ambulance officer on 95% of our calls. 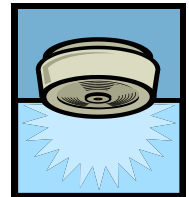
**FIRE DEPARTMENT AND AMBULANCE  
ANNUAL REPORT**

We have responded to 90 calls for service as of 3-15-13.

**FASNY STATEWIDE OPEN HOUSE:** Rush FD will have an open house April 28th from 1 pm to 4 pm. Stop in and see the equipment. Talk to the volunteers and ask questions about your fire department and ambulance service. A Rush FD history power point will be showing all day in the meeting room.

There will be refreshments. This is a statewide effort to recruit more volunteers and make the community aware of how your volunteer FD and ambulance services operate.

We will have carbon monoxide and smoke detectors available to Rush residents at no charge. Please stop by.



**FUND DRIVE:** In 2012 your volunteers responded to 384 emergency calls, that one every 23 hours. They donated over 6,000 hours to provide emergency service, attend meetings (Local, regional and state), attended training and drills, raise funds and maintain buildings and equipment. We have only ONE goal and that is to provide the best service we can for you and your family.

We are 100% volunteer, NO ONE GETS PAID! The ambulance responded to 278 calls in 2012. This included 19 Fire call standbys. We responded to 45 vehicle crashes. We have one of the last free ambulance services in the county and cover 95% of our calls with a 1st responder on scene of priority calls within 6.2 minutes of dispatch 95% of the time!

You should receive the annual fund drive letter and postage paid envelope for the **AMBULANCE** and **FIRE DEPARTMENT** operation in May.

We use fund drive money for our scouting, fire prevention programs, training, seminars and two replacement funds – one for the ambulance and the other for other vehicles and large equipment-i.e.: rescue truck, brush truck and ATV. No fund drive money is used for our few social events. Very few Fire Depts. or Ambulance services can say that!

**NEW AMBULANCE:** We are replacing our 2004 Ambulance with a 2012 Ford E-350 V-8 gas engine - Marque Modular walk-thru ambulance this spring. The cost of \$130,000 is covered by past fund drives, memorial donations and some carnival profit.

**NEW ATV AND TRAILER:** The fire department members voted to replace our ATV and trailer last month. A committee has worked on this for almost a year. Fund drive and Carnival profit will be used. The cost for both is \$15,000. We will post a photo on the web site soon.

**TAX EXEMPT STATUS:** We are a tax-exempt 501(C)3 organization. This allows anyone who donates to us to claim the donation on their income tax and for us to be tax exempt ourselves. We also are listed as a charitable organization by NYS Attorney Generals web site. We are very proud and thankful to the Rush residents who support us with donations.

**WE THANK YOU IN ADVANCE FOR YOUR CONSIDERATION!**

**PAST OFFICERS BANQUET:** Rush FD Banquet was held at RIT Inn - 103 members and guests attended. The 911 Director John Merklinger was the MC. Past Officers honored were Past President Diana Pfersick. Past Lt. Kevin Kinnally, Past Director Dale Sweet and Past Director James McNeil. Jake Vogt moved up from Captain to Asst. Chief. The "Distinguished Service" awards were given to members Diana Pfersick and Thomas Cusker.

Tom was an active member held several offices in the department when he lived in Rush. Tom served as our attorney for many years.

Diana Pfersick served as President for 10 years and was Lt. on the Ambulance for several years. She has chaired or assisted on the Past Officers Banquet, Clambake, Ladies Fun Dinner and many other projects. She served as President of the Monroe County Volunteer Firemen's Association for

two years. She received the Rush American Legion Firefighter of the Year last year and the Dunkin Donut Responder of the Year for the whole country several years ago. Diana serves on the EMS Committee of the state firefighter's organization, FASNY.

Past Fire Commissioner Steve Winner was recognized for his service as Fire Commissioner from 2003 thru 2012. Steve is also a very active member of the Rush Fire Department. He has served as a line officer, secretary and director. He also assists the Fire District and Fire Department with keeping our inventories of needed equipment, service and inspection on equipment up to date.

**LADIES AUXILIARY GIFT:** The Rush FD Ladies Auxiliary presented a check for \$2,000 to the firefighters at their Past Officers Banquet to purchase any needed equipment.

**AL SWEET RECOGNIZED:** At the Past Officer Banquet, Past Fire Chief, Past 5th Battalion Coordinator, present Fire Commissioner and active firefighter Alvin Sweet was recognized for his 60 years of active service to the Rush Fire Department. Al is the first person in our department to ever complete 60 years of active service. Al has held too many positions and chaired too many committees to list.

He has been one of the most active members the department has ever had. He shows up for every call or detail that we have. He has run the carnival parade for decades and been membership chairman for years. In 1986 Al received the "Distinguished Service" award from the Rush Fire Department.

Al served as Director, Treasurer, Vice-President and President of the Monroe County Volunteer Fire Chief's Association. In 2002 Al received the Monroe County Joint Fire Service "Firefighter of the Year" award. Al is active at the NY State level also. In 1998 he was appointed to the Fire Chief's Committee of FASNY (Firemen's Association of the State of NY) and in 2008 he was moved to the Youth's in the Fire Service Committee of FASNY.

Al stated that he could not have done what he has done all these years without the continual support from his wife Nancy who is a member of the FD Ladies auxiliary.
