Over the past 5 years, Grant money has been used to pay for many of the improvements in the Town of Rush and at the Town Hall. I have compiled a list of all grants that were approved and they are listed below.

In addition, we have submitted Grant requests for 3 additional projects. They are:

- (1.) Rush Dam Restoration \$286,230
- (2.) Preparation of a Strategic Plan for the Hamlet of Rush \$ 37,000
- (3.) Rush Town Park (adjacent to the Town Hall property) \$211,383

We will continue to seek other Grants that would improve the quality of life in the town.

Update on Current Projects

- (1.) Playground - contract awarded in early July - completion of the project expected by Labor Day.
- (2.) Emergency Generator - specifications have been written; project bidding will be held in August with installation expected by early November
- (3.) Entry Sign to Library Parking Lot - sign will be similar in appearance to the "Welcome to Rush" signs; ordered in July with installation expected by mid-September
- (4.) Additional Landscaping - plan is to begin at the Library entrance and proceed to the west along the sidewalk to the entry off Route 251; it may have to be done in 2 phases as funds budgeted for 2005 may not be enough to complete the job; requests for bids made in mid-July, with planting to begin no earlier than September
- (5.) Sidewalk extension on Rush-Lima Road - contract awarded in July with project completed by mid-September

Update of Contamination at the Rolling Plains Development - Old French Road (Town of Mendon)

This property borders on a few residential properties in the Town of Rush. The EPA conducted enforcement and disposal sampling of drums and materials on site during the week of July 19th. This consisted of characterizing the waste prior to shipment to the proper disposal location. The expectation is that by early September all drums and contaminated soil that is presently in containers will be removed from the site. Further testing may be done by the DEC. The EPA and DEC maintain direct contact with all residents of the area.

Capital Improvement 2005

The Highway Department will begin construction on Nelson Parkway the first week of August. This project will include the full reconstruction of the subdivision which will include a full drainage upgrades, new pavement and concrete gutters.

The funding for this project has been secured from the New York State Capital Highway Improvement Program (C.H.I.P.S). Capital improvements reimbursement guidelines only include types of work that have a service life of 10 years or more. The Town can only secure funding within the States fiscal year and reimbursement has to be obtained within the Town's calendar year.

In preparation for the expense of this project the Highway Department chose not to spend last years C.H.I.P.S. funding. These funds were rolled over into the current year, which doubled our funding source.

Lehigh Valley Trail

Trail construction for the North/South trail section from Pinnacle Road to the Henrietta Town line (approx. 1 mile) will be constructed this fall. Spot repairs to the East/West trail section will be completed in September along with the trail section which runs through the Veterans Park.

Town Wide Drainage

The Highway Department will be completing the drainage project in back of the Town Hall. This project will consist of extending the existing culvert 40 feet to the northeast and the installation of gabion baskets to prevent side bank erosion.

The cross culvert extension along RT15A by the Methodist Church has been completed;

this project was completed in preparation for new sidewalk installation this month.

TOWN OF RUSH FALL FESTIVAL 2005



TAXES

If you have paid off your mortgage during the last few months or will do so before the September school tax bill, please contact the town clerk's office. This will assure that the bill is sent directly to the homeowner and not the mortgage company. Any delay in receiving your bill may result in penalties being levied. State law states that you are responsible for paying taxes even if you do not receive a bill and interest fees can not be waived by the local collector.

Conservation licenses for the upcoming year, 2005-2006, will go on sale on August 15th. Please come prepared with your previous

license or a hunter's safety certificate and a driver's license or other ID.

LEGAL NOTICE OF RECEIPT OF TAX ROLL AND WARRANT

NOTICE IS HEREBY GIVEN that I, the undersigned Collector of Taxes in and for the Town of Rush, have received the Tax Roll and Warrant for the collection of taxes for the Rush Henrietta Central School for the year 2005-2006. I will receive these taxes at the Town Clerk's office, 5977 East Henrietta Road, Rush, New York, Monday, Tuesday, Wednesday and Fridays from 8:30 a.m. until 4:30 p.m. and Thursday from 8:30 a.m. until 6:00 p.m. Mailed payment should be addressed to: Linda G. Henry, Collector, and 5977 East Henrietta Road, Rush, New York 14543.

Taxes will be received interest free through October 1, 2005. Payments made after October 1, 2005 must be full payments only and will be subject to additional interest penalties of 2% per month. Full payment interest due on the total tax.

To be eligible for the partial payment option, the first payment must be made by September 15, 2005 to Linda G. Henry, Collector. Taxes paid under the installment option **MUST MAKE THE SECOND AND THIRD INSTALLMENT PAYMENTS DIRECTLY TO THE MONROE COUNTY TREASURY.**


Taxes are payable to the Town of Rush until October 31, 2005, when the Tax Rolls will be returned to the County of Monroe on November 1, 2005. Further information about payment, interest charge and payment location can be found on the back of the tax bill.

Taxpayers who pay by mail should consider their cancelled check as their receipt. **RECEIPTS WILL BE ISSUED FOR PAYMENT ONLY WHEN REQUESTED AND IF THE ENTIRE TAX BILL IS SENT WITH PAYMENT.**



The Assessor’s office has new hours which are reflected above. Hopefully our expanded hours will be more convenient for everyone. I have a new Clerk, Deb Curran, who will be in the office **Monday through Thursday from 8:30 a.m. to 12:15 p.m.**

The second topic that I wanted to cover is the Town’s status in the NYS Annual Assessment Program. Preliminary feedback from the Batavia Office of Real Property Services (“ORPS”) indicates that assessments have fallen out of “spec” from state requirements. ORPS will be doing further statistical analysis this fall along with the town’s own review and, at that point, formulate a plan for implementation for 2006. It seems likely that the residential portion of the assessment roll will need to be updated for 2006.

I hope everyone is enjoying this hot and humid summer season and are able to find some way to stay a little bit cool.

FIRE DISTRICT: You are reminded that it is **your responsibility** to have access for emergency equipment onto your property. **Recently our crews have had problems getting in with the ambulance due to low branches and bushes,** This slows our response and could damage our vehicles. **The lack of visible house numbering remains a problem!** The parking lot at station one (west side) will have a new asphalt topping and the apparatus driveway will be sealed in August. It is budget time again; it is our goal to keep the tax rate where it is for 2006.

FIRE DEPARTMENT & AMBULANCE: We have responded to **200 calls as of July 20th.** The ambulance service remains very busy.

The firefighters made quick work extinguishing two bedrooms and the attic at 19 Birchstone Hill in June. We used 300 gallons of water and class A foam to put the fire out. A candle started this fire.

Sean Brown was voted in as an active member. He was an explorer for several years.

The fire department, color guard and FD band have been winning a lot of prizes at area parades. Pumper 582 has won several first place prizes in truck competitions. CARNIVAL & PARADE: We had a very good carnival. Friday it rained all day and at 6:15 the sun came out! The parade was a little shorter but many bands did show up. Many residents, friends and family members assisted the active, social and auxiliary members at the carnival. Rush Gravel Corp. brought in stone for midway that washed out due to the heavy rains. Vern Valance (Roger Tobey) took care of the septic service needs. Luther Keyes (Hickory Hill Construction), Tim Lincort and Rob Rowland (Rush Storage) provided equipment to assist at the event. Gary Lambert (Rush Market) assisted the men and ladies. All-Temp Refrigeration of

Honeoye Falls got a used ice machine donated to the department. Boy scout Troop 334 sold out at their famous chicken barbeque!

Our neighboring fire and ambulance squads covered the town on the carnival dates from our station for any calls that came in. It is a lot of work. The firefighters set the carnival up in 4 hours and tore it down in 3 hours. Almost 100% of the active members show up and work at the carnival. Go to carnival on the web site for photos.
