COUNTY OF MONROE INDUSTRIAL DEVELOPMENT AGENCY (COMIDA) UNIFORM TAX EXEMPTION POLICY NOTICE OF PUBLIC HEARING

PLEASE TAKE NOTICE THAT A SPECIAL MEETING OF THE COUNTY OF MONROE INDUSTRIAL AGENCY (AGENCY) WILL BE HELD ON FEBRUARY 14, 2008, AT 7:00 O'CLOCK P.M., AT THE EBENEZER WATTS CONFERENCE CENTER, 49 SOUTH FITZHUGH STREET, ROCHESTER, MONROE COUNTY, NEW YORK 14614. THE SPECIFIC PURPOSE OF THE MEETING IS TO DISCUSS RENEWING AND/OR AMENDING THE AGENCY'S UNIFORM TAX EXEMPT POLICIES AND, ADDITIONALLY, TO SPECIFICALLY CONSIDER A NEW PROGRAM TO ASSIST LARGE EDUCATIONAL AND HOSPITAL INSTITUTIONS IN CONNECTION WITH MEDICAL OFFICES AND/OR CENTERS AND RELATED FACILITIES. THESE POLICIES PROVIDE GUIDELINES FOR THE CLAIMING OF REAL PROPERTY, MORTGAGE RECORDING AND SALES TAX EXEMPTIONS.

2007 ANNUAL AID CERTIFICATION

We have been notified by the State Office of Real Property Services that we have successfully completed the annual reassessment of our 2007 Assessment Roll. As a result of this, we will be receiving State Aid of \$5.00 per parcel x 1716 parcels = \$8,580.00. This is the 6th year that we have received aid under the State program. The goal of this program is to maintain equitable assessments that reflect current market value. The 2007 reassessment for which this payment is being provided is part of a 6 year plan that we had submitted. The 6 year plan includes maintaining assessments at 100 percent of market value on a yearly basis. In order to continue receiving state aid, we must continue to comply with the standards for annual reassessments.

GREENWAY PROJECT REPORT ON COMMUNITY WORKSHOP #2

On January 7th, from 3:30 p.m. to 5:00 p.m., approximately 30 members of the Steering and Citizens' Committees met at the Rush Town Hall. The purpose was to state the findings of the November 7th meeting and review progress on the Greenway Project.

Actions/Activities Since Last Meeting:

a. Larsen engineers has received a copy of the geotechnical engineer's report on the Rush Dam and is evaluating short and long term repair options.

b. Review (past planning studies) to determine relevancy to Greenway Project.

c. Genesee Finger Lakes Regional Planning (GFLRP) has completed inventory maps of natural features, regulated environmental areas, land cover, and public land. They will continue with maps from real property records. The maps will be posted on the web site.

d. The Mendon Foundation has installed mile markers along the length of the Lehigh Valley Trail and the GPS locations of these markers has been added to the Monroe County Emergency Base for 911 purposes.

PROCEDURAL AND ADMINISTRATIVE ISSUES

It was decided that subcommittees would be appointed to review individual report chapters, rather than each person reviewing the whole document.

It was decided that each committee member would complete the questionnaire that is downloadable from the public website, and on it also add their comments or additional recommendations on the Rochester Regional Community Design Center Workshop (RRCDC) report.

It was decided that more representation on the citizen advisory committee would be beneficial. Rush Town Councilman Richard Anderson volunteered to coordinate this task. All committee members are encouraged to suggest groups or persons to him. Rich can be reached at rich@townofrush.com.

It was decided that the workshop summary report should go on the public website, but must be accompanied by an explanation of its purpose and how it fits into the planning process.

Everyone in attendance favored the password protected website as a good way to communicate. We would also like the opinion of those who did not attend.

NEXT STEPS

1. Review summaries of past documents that will be on the password protected website the week of February 13th.

2. GFLRPC to complete the mapping and put the maps on the public website.

3. A target date of mid February was set for completion of special reports from contract organizations.

4. Complete individual questionnaires that can be found on the public website. Add your comments on the Workshop summary report.

5. The Consultant will begin to prepare report chapters.

6. The Consultant will prepare the introduction to the workshop summary.

FIRE DISTRICT: The organizational meeting was held on January 2nd. Bob Faugh was elected as Chairman and Larry Meston was elected as Vice-Chairman of the Board of Fire Commissioners. Robert Kuhls was appointed as Treasurer and Karen Wanderslaben was appointed to the Secretary position. The Fire Commissioners meeting will be held the third Tuesday, 7 pm at station one. All of our meetings are open to the public.

The electrical storm in November caused damage to the EMS antenna and radio at station one. It blew out a \$1,400 radio power booster, several computers and some other electrical equipment. A claim has been submitted to the insurance company. The recent storm in January damaged the FD lit sign and it is being repaired by Wayne Burdett.

FIRE DEPARTMENT AND AMBULANCE: The line officers for the department were approved by the Board of Directors at the January meeting. All are listed on the web site. The active and social officers are also listed.

ANNUAL REPORT: Total of 382 Fire & EMS Calls for 2007. That is a call every 23 hours. **Structure fires or Fire in a Structure 6,** (Average of 15 F/Fs responded) **Vehicle Fires 6,** (Vehicle was on Fire) (Average of 12 f/f's responded) **Trash, Brush, Weeds or Grass 9,** (was a fire) (Average of 16 f/f's responded) **Automatic Alarms - Good intent calls 53 or 1/3 of the Fire type calls.** (Average 7 f/f's responded) **Mutual Aid fill ins or to the scene 12, General Ambulance calls** (Average 8 f/f's responded) Response to MVA's 49 of which 25 had no patients to be transported. (Average of 13 f/f's

responded) **Calls canceled, wrong location (town), no incident found 16.** The remaining calls were wires, dangerous conditions, CO Alarms, etc.

Total Ambulance Calls 215 (11 Mutual Aid to Henrietta) (Average 7 f/f's responded - MVA's not included) Transported 122 patients or 57% of the calls for the Ambulance. 22 patients were transported by an ALS (Advance Life Support) Ambulance to the Hospital. In addition we had an ALS fly car on 64 calls - 60 provided by Henrietta Vol. Ambulance. **Total ALS Patients transported from Rush 82.** ALS Cancelled on 27 calls. Transported to hospitals, 66 Patients to Strong, 44 to Highland, 2 to Park Ridge, 7 to RGH, 1 to Noyes, 2 to Thompson.

Our average response time to get a properly equipped "first responder" EMT on scene was 5 minutes 90% of the time. This response time is exceptional and beat almost everyone in Monroe Co. most of which are paid services. We have two "first responder" officers cars equipped with automatic defibrillators and several others with basic life support equipment that respond to the scene.

2,790 man/women hours were expended on these calls. All these hours were donated by your relatives, friends and neighbors. Another 3,500 hours were donated for training, seminars, drills, carnival, maintenance on equipment/ buildings and local, regional and state meetings.

FUND DRIVE: We have received over \$55,000 from the 2007 annual fund drive. **Thank you very much!** The per resident donation is unmatched ANYWHERE in western NY state. This years money is going for new %aws of Life+ equipment (\$33,000) Footware (\$3,000), General operations such as Fire Prevention, Girl/ Boy Scouts and Explorer sponsorships, training/seminars, fire and EMS equipment, office costs and the rest into Rescue Truck and Ambulance replacement funds. No fund drive money is ever used for our few social functions.

FIRE PREVENTION: Keep up the good work, watch those candles and wood stoves. Keep the hydrant near your home clear of snow. Let's continue to have a safe winter!

EXPLORERS: We have seven explorers at this time. Any boy or girl between 14 and 21 may apply. They plan a field trip to the 9-1-1 center very soon. They had a dinner with members and parents in December at station one. 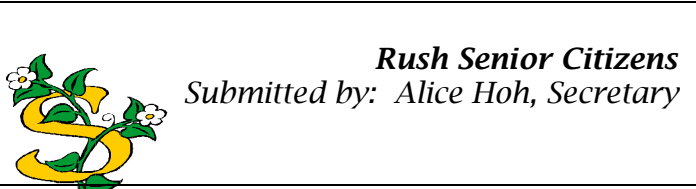

NOTICE OF PUBLIC HEARING

PLEASE TAKE NOTICE, THE RUSH TOWN BOARD WILL HOLD A PUBLIC HEARING ON FEBRUARY 13,

2008, AT 7:15 PM AT THE RUSH TOWN HALL, 5977 EAST HENRIETTA ROAD TO CONSIDER THE ADOPTION OF THE THREE FOLLOWING LOCAL LAWS. AT THIS TIME THE BOARD WILL HEAR ALL PERSONS IN SUPPORT OR OPPOSED TO THESE LAWS. THE PROPOSED CHANGES AS SHOWN BELOW OR COPIES OF THE PROPOSED LOCAL LAWS ARE AVAILABLE FOR INSPECTION AT THE TOWN CLERK'S OFFICE DURING NORMAL BUSINESS HOURS.

**LOCAL LAW NO. 2 OF 2008
TAX EXEMPTION GRANTED TO PERSONS AGE 65 OR OVER**

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF RUSH, AS FOLLOWS:

Pursuant to the authority granted by Section 467 of the Real Property Tax Law, as last amended by Chapter 512 of the Laws of 2003 for the State of New York, Section 103-2 of the Code of the Town of Rush, is hereby amended as follows:

"An exemption shall be granted if the income of the owner or the combined income of the owners of the property for the income tax year immediately preceding the date of making application for exemption and will be made according to the following schedule:

ANNUAL INCOME	% ASSESSED VALUATION EXEMPT FROM TAXATION

This Local Law will supercede and amend the income guidelines established in Section 103-2 of the Code of the Town of Rush as amended by Local Law No. 3-2004. This Local Law shall become effective after filing and acknowledgment by the Office of the Secretary of State pursuant to Section 26 of the Municipal Home Rule Law.

**LOCAL LAW NO. 3 OF 2008
TAX EXEMPTION FOR PERSONS WITH SOCIAL SECURITY CLASSIFIED DISABILITIES**

Pursuant to the authority granted by Section 459-c of the Real Property Tax Law, as last amended by Chapter 462

of the Laws of 2003 of the State of New York, Section 103-11 of the Code of the Town of Rush, as last amended by Local Law No. 2 of 2002, is hereby amended as follows:

"An exemption shall be granted if the income of the owner or the combined income of the owners of the property for the income tax year immediately preceding the date of making application for exemption and will be made according to the following schedule:

ANNUAL INCOME	% ASSESSED VALUATION EXEMPT FROM TAXATION
Less than \$27,000	50 per centum
More than \$27,000, but less than \$28,000	45 per centum
More than \$28,000, but less than \$29,000	40 per centum

More than \$30,900, but less than \$31,800	25 per centum
More than \$31,800, but less than \$32,700	20 per centum
More than \$32,700, but less than \$33,600	15 per centum

More than \$34,500, but less than \$35,400	05 per centum

The eligible income levels will then increase \$1,000 annually through 2009, such that in 2009 there will be a 50% exemption for incomes up to \$29,000 and a graduated reduction in exemption for incomes more than \$29,000 but less than \$37,400."

This Local Law will supercede and amend the income guidelines established in Section 103-11 as last amended by Local Law No. 2 of 2002. This Local Law shall become effective after filing and acknowledgement by the Office of the Secretary of State pursuant to Section 27 of the Municipal Home Rule Law.

LOCAL LAW NO. 4 OF 2008

AMENDING ARTICLE IV OF THE CODE OF THE TOWN OF RUSH

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF RUSH, AS FOLLOWS:

Section 103-10 of Article IV of the Code of the Town of Rush to be entitled "Cold War Veterans' Exemption," shall be established as follows:

"Section 103-10 - Cold War Veterans' Exemption Pursuant to the authority granted by Section 458-b of the Real Property Tax Law, where a Cold War Veteran (persons who rendered military service to the United states during the Cold War (September 2, 1945, to December 26, 1991), received compensation from the United States Veteran's Affairs or from the United States Department of Defense because of a service related disability, qualifying residential real property shall be exempt from taxation to the extent of the product of the assessed value of such property, multiplied by fifty

percent (50%) of the Cold War Veteran disability rating; provided however, that such exemption shall not exceed \$40,000.00. Such exemption shall be granted only upon application by the owner(s) of such real property on a form prescribed by the State Board of Real Property Services. The application shall be filed with the Town Assessor on or before the first appropriate taxable status date for the Town of Rush. The Town Board may, from time-to-time, amend, supplement, change, modify or repeal this Article pursuant to the provisions of the Town Law, the General Municipal Law, and the Real Property Tax Law of New York State applicable thereto." This Local Law shall become effective after filing and acknowledgment by the Office of the Secretary of State pursuant to Section 27 of the Municipal Home Rule Law.

At such hearing, any person may be heard in favor of or against the revisions as proposed at the above time and place.

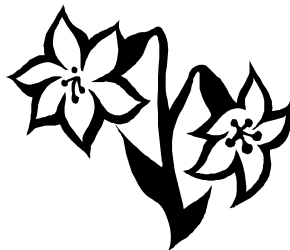
